	We can only offer a limited range of mortgages from a single lender We only offer our own mortgages.
3.	Which service will we provide you with?
<u> </u>	We will advise and make a recommendation for you after we have assessed your needs.
	You will not receive advice or a recommendation from us. We may ask some questions to narrow down the selection of products that we will provide details on. You will then need to make your own choice about how to proceed.
4.	What will you have to pay us for this service?
	No fee, we will be paid by commission from the lender.
$\overline{\mathbf{V}}$	A fee of £895 payable when you apply for a mortgage. We will also be paid commission from the lender after the mortgage completes. An additional non-refundable fee of 0.5% of the amount borrowed is payable on receipt of mortgage offer for any Non-Residential Capital Raising / Special Status or for any Non-Conforming mortgage schemes
You will receive a key facts illustration when considering a particular mortgage which will tell you about any fees relating to it.	
5.	Refund of fees
If we	charge you a fee, and your mortgage does not go ahead, you will receive:
	A full refund, if the lender rejects your application.
	A refund of \pounds , if the purchase falls through.
$\overline{\checkmark}$	No refund is payable if you decide not to take out a mortgage.
